### **RULES AND REGULATIONS**

**By law, all pool gates must be kept closed**

- ◆ Everyone must shower prior to entering the pools.
- ◆ Only waterproof sun blocks or greaseless lotions are permitted; suntan oils are not permitted.
- ◆ Glass containers are strictly prohibited.
- ◆ Food/snacks are prohibited in the pool deck area.
- ◆ All forms of smoking are strictly prohibited in the pool deck area, including vaping.
- ◆ Those with long hair must secure it up or wear a bathing cap.
- ◆ Only swimwear is permitted in the water. No clothing permitted in the pool.
- ◆ Wet swimwear is not permitted in any of the facilities, except the restroom areas.
- ◆ In consideration of other residents, please limit guests to six (6).
- ◆ No running, diving, or jumping into the water.
- ◆ **No children under the age of three (3) are permitted in the pools.**
- ◆ **All children under the age of eighteen (18) must be accompanied by an adult.**
- ◆ Absolutely no diapers of any kind are allowed in the pools.
- ◆ Persons using the pool area are responsible for cleaning the area after their use.
- ◆ Pets are strictly prohibited in the pool area.
- ◆ Personal radio/music devices are permitted only if used with earphones.
- ◆ Only water wings, noodles, and noodle sling chairs are permitted as floatation devices.
- ◆ No bicycles allowed inside the pool area fence.
- ◆ Pool water temperature is maintained at 86 degrees. The spa is heated to 103 degrees.

## RULES AND REGULATIONS

**By law, all pool gates must be kept closed**

- ◆ ALL POOL RULES APPLY TO THE SPA.
- ◆ No children under the age of eighteen (18) allowed in the spa.
- ◆ Persons with health conditions, i.e., heart disease, diabetes, high or low blood pressure, or are pregnant, should consult a physician before using the spa.
- ◆ Do not use the spa if under the influence of alcohol, tranquilizers, or other drugs that cause drowsiness or that raise or lower blood pressure.
- ◆ Recommended time limit: ten to fifteen (10-15) minutes in the spa, cool down before returning. Long exposure may result in nausea, dizziness, or fainting.
- ◆ Maximum occupancy is twelve (12) individuals.
- ◆ All forms of smoking are strictly prohibited in the pool deck area, including vaping.
